

Section 1: Inflatabilities, LLC.'s Responsibility¹

- _____ I have been shown and understand how inflatable(s) is secured (either with in-ground stakes and/or weights).
- _____ I have been shown and understand how to operate the blower. I know how to to secure the blower(s) to the unit, to turn it on/off, and how each blower is plugged in.
- _____ The inflatable and/or game has been set up in an operational safe manner. The equipment is not set-up on an incline/decline of more than 35 degrees. Rental equipment has not been set-up in the vicinity of power lines, trees, or any other potentially hazardous objects.
- _____ I have received verbal instruction pertaining to the safe operation of inflatable(s) and/or rental equipment and agree to follow all safety rules. I have been made aware of the written regulations posted on the actual unit(s).
- _____ I have been instructed to prohibit any and all dangerous-harmful activity in, on, and around the inflatable(s) and rental equipment. This includes but is not limited to: horseplay, acrobatic maneuvers (e.g. Flips, Handstands, etc.), wrestling, shoving, uncontrolled jumping, and so forth.
- _____ I have been advised of the following prohibitions:
 - All shoes, cellular devices, and keys must be removed and stored away from the inflatable(s).
 - Food, candy, gum, beverages, and so forth are expressly forbidden while on the inflatable(s).
 - Eyewear, jewelry, sharp objects are not allowed on or near the inflatable(s).
- _____ I have been advised and understand that only children of the same size and/or age group may use the unit(s) at any given time. I have been advised and instructed on the various weight and number limits of participants. Unless otherwise instructed, adults may not utilize the inflatable unit(s).

Section 2: The Lessee's Responsibility²

- _____ I understand that a competent adult (18+ years of age) must be provided to attend the inflatable(s) and/or rental equipment at all times during its operation and/or utilization. Only adults who have been briefed by an Inflatabilities, LLC. staff member or the lessee qualify to attend the unit(s).
- _____ I agree to remove any person from the inflatable who is violating any safety regulation and written rules of operation posted on each inflatable. Persons who violate the safety regulations will be banned from using the inflatable(s) for the duration of the rental period.
- _____ I will, in the event of inclement weather (as described in the rental terms and conditions), cease operation of the inflatable(s) and rental equipment, turn off the blower(s), unplug the units, and contact Inflatabilities, LLC.
- _____ I will contact Inflatabilities, LLC. and/or one its agents, if I should have any additional questions regarding operation or safety procedures of the rental equipment.
- _____ I will contact Inflatabilities, LLC. and/or one its agents, if an accident or injury occur during rental period. I will also document, in detailed written format, any accident and/or injury that occurs and submit that information to Inflatabilities, LLC. upon request.
- _____ I will contact a medical professional and/or emergency medical services, if a significant injury should occur.
- _____ I will contact Inflatabilities, LLC. and/or one its agents, if the inflatable(s) and/or rental equipment breaks, malfunctions, or otherwise ceases to correctly operate during the rental period.
